

## **Plenty Foods Competition**

## **Terms and Conditions**

- 1. The Promoter is: Plenty Foods Pty Ltd (ACN 146 627 303) of registered office: 67 William St, Kingaroy QLD 4610 ('Promoter').
- 2. Employees of the Promoter or their family members or anyone else connected in any way with the competition or helping to set up the competition shall not be permitted to enter the competition.
- 3. To enter the competition, entrants must:
  - a. Permanently reside in Queensland, New South Wales or Victoria;
  - Record and upload a link to a video of the entrant cooking a recipe of their choice ('Home Cook Video');
  - c. Visibly incorporate use of any Plenty Foods cooking oil product in the video; and
  - d. Submit the recorded video entry using the form located on this promotional website page: <a href="https://www.plentyfoods.com.au/competition">www.plentyfoods.com.au/competition</a>.
- 4. Entrants are responsible for deciding which hosting provider they would like to use to store their video entry. It must be able to provide a link (URL) to the video. The Promoter suggests entrants consider using YouTube, Google Drive, Dropbox or similar file hosting providers that do not cost anything. These (and other) providers allow URLs to be created for this purpose. The URL is to be inserted into the entry form outlined above at clause 3(d).
- 5. Closing date for entry will be 5pm (AEST) Tuesday 15<sup>th</sup> November 2022. After this date no further entries to the competition will be permitted.
- 6. The Promoter does not accept any responsibility for entries not received, for whatever reason.
- 7. The rules of the competition and the prize for each winner are as follows:
  - a. For each Home Cook Video that the entrant submits, the entrant receives 1 entry into the competition.
  - b. Entrants may enter more than once, provided the submitted Home Cook Video contains a different recipe.
  - c. There will be two (2) winners selected by a panel of three (3) judges (determined and appointed by the Promoter).
  - d. Winners will be selected on the basis of submitting the "most delicious recipes that best use a Plenty Foods oil". This determination shall be made by the judging panel and the panel's decision is final. As such, no further correspondence shall be entered into.
  - e. The first prize winner shall receive a restaurant voucher valued at \$400 (\$AUD) to be redeemed at a restaurant of their choosing. The first prize winner must nominate the restaurant of their choice and the Promoter will provide a suitable gift voucher to said restaurant.
